Subject: Observance of Vigilance Awareness Week – 2013.

Central Vigilance Commission being the premier integrity institution of country, in its endeavour to promote integrity in various Central Government offices and public sector undertakings, observes Vigilance Awareness Week every year wherein all the stake holders participate. The Commission has decided that this year the Vigilance Awareness Week would be observed from 28th October (Monday) to 2nd November (Saturday), 2013. The observance of the Vigilance Awareness Week would commence with the pledge (copy enclosed) on 28th October, 2013 at 11.00 a.m. This year the theme of observing Vigilance Awareness Week is "Promoting Good Governance – Positive Contribution of Vigilance".

2. Governance is the exercise of economic, political and administrative authority to manage a country's affairs at all levels. It consists of the mechanisms, processes and institutions through which citizens and groups articulate their interests, exercise legal rights, meet obligations and mediate differences. Without good governance, no amount of developmental schemes can bring in improvements in the quality of life of the citizens. Strengthening governance, therefore is vital and over the recent past, several initiatives have been undertaken to improve the quality of governance. However, a lot more remains to be done. Improved governance in the form of eliminating corruption by strict action in respect of tax evasions and black market economy as well as increased transparency in public procurements, is very necessary. Enforcing accountability, alongwith addressing bureaucratic delays and effective public grievance redressal mechanism is the way forward.

3. Experience has shown that increased transparency, competition, and leveraging of technology lead to decline in corruption. There is a need to institutionalise best practices and sustained efforts are required to identify and document such practices. The Commission as the apex integrity institution has therefore, been advocating transparency, fairness, equity and encouraging competitiveness as well as leveraging of technology in all areas of functioning of the Government and its organisations. Promoting good governance is, therefore, the focus of the vigilance awareness campaign this year. Vigilance administration can contribute effectively in this regard by sensitising the people at large as well as the public servants in the organisations by showcasing the positive contribution of vigilance efforts in the organisation during the year e.g. (i) if procurement is handled electronically, the savings achieved since introduction of e-procurement, (ii) if enterprise wide computerisation has been done, the outcomes thereof, (iii) systemic changes introduced etc.

4. Ministries/Departments/PSUs/Banks/Organisations are advised to consider the following activities during the Vigilance Awareness Week:-

- (i) To display banners, posters etc, at prime locations in their offices;
- (ii) To organize seminars/workshops relevant to the theme inviting prominent faculty;
- (iii) To organize debates/lectures/essay writing competitions on moral values, ethics, good governance practices etc., amongst the employees and students in the colleges/schools in local areas and to distribute prizes;
- (iv) To bring out special issue of journals during the period; and
- (v) To request the non-government organizations, institutions and service associations in the local area to participate in the vigilance awareness campaign.

5. Public Sector Enterprises, societies and local authorities are also advised that message (pledge) may be read to Board of Directors by respective Chairman in the Board/Governing body meeting being held prior to the Vigilance Awareness Week.

6. A report on observance of the Week may be sent to the Central Vigilance Commission by 15th December, 2013 by all Departments/Organisations.
