

3. There should not be any overwriting or corrections in the tenders. If the figure is required to be amended, it should be neatly scored out, the revised figure written above and the same attested with signature and date; otherwise their tender will be liable for rejection.
4. In the event of acceptance of the quotation and placing of the order for purchase, the articles ordered may be subjected to an inspection by any representative of KVS [HQ] and are liable to be rejected if the articles supplied are not according to the specifications given in tender document.
5. If the supplier fails to supply any quantity of materials within the time stipulated in the supply order, the undersigned will be at liberty to cancel the order and procure the materials from other sources and the EMD amount shall stand forfeited.
6. It would not be binding upon the authority to accept the lowest tender. The authority reserves the right to accept the tender in whole or in part, as may be decided. Any dispute shall be subject to the jurisdiction of appropriate Hon'ble Courts of Delhi.
7. **EMD/Bid Security :**
 - (a) The EMD/Bid Security of Rs.10,000/- (Rs.Ten Thousand Only), will be deposited by the tenderer through bank DD / Pay order (cheque not acceptable) drawn in favour of the "Kendriya Vidyalaya Sangathan New Delhi".
