3. The AMAs are requested NOT to prescribe medicines for more than 10 days at a stretch from the very beginning of the treatment. In course of 3 to 4 consultations, she can reach to 20 days, i.e. maximum period of treatment.

4. The AMAs are further requested to strictly follow the rules and orders issued under CS (MA) Rules 1944 and to note the salient points set out in the same rules. A copy of "INSTRUCTIONS FOR DOCTORS" as in Appendix-XI of Medical Attendance Rules is enclosed (*not printed*).

**CS (MA) Rules, 1944 — Renewal of name of the AMA for the  
treatment of Central Government Employees and Members  
of their family for the period from 1-8-2013 to 31-7-2014**

In terms of Ministry of Health and Family Planning's (Department of Health), instructions contained in O.M. No. 9-14025/133/79-MS, dated 28-5-1982 and C & A.G Circular No. 445-Audit/1787/III-90(86), dated 10-8-1990 and as per Rule 2-A (iv) of the CS (MA) Rules 1944, the name of the following Private Medical Practitioners are renewed as Authorized Medical Attendants during the normal working hours for the treatment of the Central Government Employees and members of their family residing at the station mentioned against each (AMA) within a radius of 16 km. thereof for a period of one year, i.e. 1-8-2013 to 31-7-2014 which are falling outside the definition of city limit of Kolkata and not covered by CGHS.

**(IMPORTANT NOTE FOR THE AMAs  
TO BE OBSERVED STRICTLY)**

AMAs are requested to submit applications for renewal at least 3 months before the date of expiry of present term. The CGEWCC reserves the right to delete any name due to non-receipt of application for renewal in time.

AMAs are requested not to prescribe medicines for more than  $\frac{3}{4}$  days at a time. However, in case of  $\frac{3}{4}$  consultations, the treatment should be restricted to maximum period of ten days. The fees for consultation and injection should be taken as per GI., M.H., O.M. No. S-14025/10/2010-MS, dated 17-3-2011 of Ministry of Health and Family Welfare (Department of Health), New Delhi.

Any change in address / degree, etc. should be intimated immediately with documentary evidence. In case of death of AMA, an intimation has to be sent to the Secretary, CGEWCC, Kolkata by the nearest relative of the AMA with a copy of death certificate.

**Recognition of Aayush NRI LEPL Health Care Pvt. Ltd.,  
Vijayawada, Andhra Pradesh for treatment of Central Government  
employees under CS (MA) Rules, 1944**

The undersigned is directed to say that the proposal received for recognition of Aayush NRI LEPL Health Care Pvt. Ltd., Vijayawada (Andhra Pradesh) for treatment of Central Government Employees and their family members under CS (MA) Rules, 1944 was under consideration.

2. In view of the hardship faced by CS (MA) beneficiaries for their own treatment and the treatment of their family members at Vijayawada, (Andhra Pradesh), the matter has been examined in the Ministry and it has been decided to empanel Aayush NRI LEPL Health Care Pvt Ltd., Vijayawada. (Andhra Pradesh) under Central Services (Medical Attendance) Rules, 1944.

3. The Schedule of charges for the treatment of Central Government Employees and the members of their family under the CS (MA) Rules, 1944, will be the rates fixed for CGHS, Hyderabad. The approved rates are available on the website of CGHS ([www.mohfw.nic.in/cghs.html](http://www.mohfw.nic.in/cghs.html)), and may be downloaded / printed.

4. The undersigned is further directed to clarify as under:—

(a) "Package Rate" shall mean and include lumpsum cost of in-patient treatment / day care / diagnostic procedure for which a CS (MA) beneficiary has been permitted by the competent authority or for treatment under emergency from the time of admission to the time of discharge, including (but not limited to)-(i) Registration charges, (ii) Admission charges, (iii) Accommodation charges including patient's diet, (iv) Operation charges, (v) Injection charges, (vi) Dressing charges, (vii) Doctor / consultant visit charges, (viii) ICU/CCU charges, (ix) Monitoring charges, (x) Transfusion charges, (xi) Anaesthesia charges, (xii) Operation theatre charges, (xiii) Procedural charges / Surgeon's fee (xiv) Cost of surgical disposables and all sundries used during hospitalization, (xv) Cost of medicines, (xvi) Related routine and essential investigations, (xvii) Physiotherapy charges, etc, (xviii) Nursing care and charges for its services.

(b) Cost of implants is reimbursable in addition to package rates as per CGHS ceiling rates for implants or as per actual, in case there is no CGHS prescribed ceiling rates.

(c) Treatment charges for new born baby are separately reimbursable in addition to delivery charges for mother.

(d) Aayush NRI LEPL Health Care Pvt. Ltd., Vijayawada (Andhra Pradesh) shall not charge more than the package rates fixed for CGHS, Hyderabad.

(e) Expenses on toiletries, cosmetics, telephone bills etc., are not reimbursable and are not included in package rates.

5. Package rates envisage duration of indoor treatment as follows:

- Up to 12 days : for Specialized (Super Specialities) treatment
- Up to 7 days : for other Major Surgeries
- Up to 3 days : for Laparoscopic surgeries / normal deliveries
- 1 day : for day care / Minor (OPD) surgeries.

No additional charge on account of extended period of stay shall be allowed if that extension is due to infection on the consequences of surgical procedure or due to any improper procedure and is not justified.

In case, there are no CGHS prescribed rates for any test / procedure, then AIIMS rates are applicable. If there are no AIIMS rates, then reimbursement is to be arrived at by calculating admissible amount item-wise (e.g. room rent, investigations, cost of medicines, procedure charges, etc.) as per approved rates / actual, in case of investigations.

6. (a) CS (MA) beneficiaries are entitled to facilities of private, semi-private or general ward depending on their basic pay. The entitlement is as follows:—

S. No.	Pay drawn in pay band	Ward Entitlement
1.	Up to ₹ 13,950	General Ward
2.	₹ 13,960 to 19,530	Semi-Private Ward
3.	₹ 19,540 and above	Private Ward

(b) The package rates given in rate list are for semi-private ward.

(c) The package rates prescribed are for semi-private ward. If the beneficiary is entitled to general ward, there will be a decrease of 10% in the rates; for private ward entitlement, there will be an increase of 15%. However, the rates shall be same for investigation irrespective of entitlement, whether the patient is admitted or not and the test, *per se*, does not require admission.

7. The hospital shall charge from the beneficiary as per the CGHS prescribed rates or its own rate list, whichever is lower.

8. (a) The maximum room rent admissible for different categories would be:

General ward	₹ 1,000 per day
Semi-private ward	₹ 2,000 per day
Private ward	₹ 3,000 per day
Day care (6 to 8 Hrs.)	₹ 500 (same for all categories)

(b) Room rent mentioned at (a) above is applicable only for treatment procedures for which there is no CGHS prescribed package rate.

Room rent will include charges for occupation of bed, diet for the patient, charges for water and electricity, linen charges, nursing charges and routine upkeeping.

(c) During the treatment in ICCU / ICU, no separate room rent will be admissible.

(d) Private ward is defined as a hospital room where single patient is accommodated and which has an attached toilet (lavatory and bath).

The room should have furnishings like wardrobe, dressing table, bed-side table, sofa set, etc., as well as a bed for attendant. The room has to be air-conditioned.

(e) Semi Private ward is defined as a hospital room where two to three patients are accommodated and which has attached toilet facilities and necessary furnishings.

(f) General ward is defined as hall that accommodates four to ten patients.

(g) Normally, the treatment in higher category of accommodation than the entitled category is not permissible. However, in case of an emergency when the entitled category accommodation is not available, admission in the immediate higher category may be allowed till the entitled category accommodation becomes available. However, if a particular hospital does not have the ward as per entitlement of beneficiary, then the hospital can only bill as per entitlement of the beneficiary even though the treatment was given in higher type of ward.

If, on the request of the beneficiary, treatment is provided in a higher category of ward, then the expenditure over and above entitlement will have to be borne by the beneficiary.

9. In case of non-emergencies, the beneficiary shall have the option of availing specific treatment / investigation from any of the recognized hospitals of his / her choice (provided the hospital is recognized for that treatment procedure / test), after the specific treatment / investigation has been advised by Authorized Medical Attendant and on production of valid ID card and permission letter from his / her concerned Ministry / Department.

10. The hospital shall honour permission letter issued by Competent Authority and provide treatment / investigation facilities as specified in the permission letter.

11. The hospital shall also provide treatment / investigation facilities to the CGHS beneficiaries and their eligible dependent family members at their own rates or rates approved under CS (MA) Rules, whichever is lower. The hospital shall provide treatment to such pensioner CGHS beneficiaries after authentication through verification of valid CGHS Cards.

12. However, pensioner CGHS beneficiaries would make payment for the medical treatment at approved rates as mentioned above and submit the medical reimbursement claim to the Additional Director, CGHS through the CMO in charge of the CGHS Wellness Centre, where the CGHS Card of the beneficiary is registered.

13. In case of emergencies, the beneficiary shall have the option of availing specific treatment / investigation from any of the above-mentioned



hospitals of his/her choice (provided the hospital is recognized for that treatment procedure / test), on production of valid ID card, issued by Competent Authority.

14. During the in-patient treatment of the CS (MA) beneficiary, the Hospital will not ask the beneficiary or his attendant to purchase separately the medicines / sundries / equipment or accessories from outside and will provide the treatment within the package rate, fixed by the CGHS which includes the cost of all the items.

15. In case of treatment taken in emergency in any non-recognized private hospitals, reimbursement shall be considered by Competent Authority at CGHS prescribed package / rates only.

16. If one or more minor procedures form part of a major treatment procedure, then package charges would be permissible for major procedure and only 50% of charges for minor procedure.

17. Any legal liability arising out of such services shall be the sole responsibility and shall be dealt with by the concerned empanelled hospital. Services will be provided by the Hospital as per the terms given above.

18. Ministry of Health and Family Welfare reserves the right to withdraw / cancel the above recognition without assigning any reason.

19. The order takes effect from the date of issue of the O.M.

20. The authorities of Aayush NRI LEPL Health Care Pvt. Ltd., Vijayawada (Andhra Pradesh) will have to enter into an agreement with the Government of India to the effect that the Hospital shall charge from the Central Government employees at the rates fixed by the Government and they will have to sign a Memorandum of Understanding (MoU) (*2 copies enclosed only for Hospital*) within a period of 3 months from the date of issue of the above-mentioned OM failing which the Hospital will be derecognized. Subject to above, the Hospital can start treating Central Government employees covered under CS (MA) Rules, 1944.

Sub:- Issue of Identity Cards to Central Government Pensioners —reg.

The undersigned is directed to say that instructions were issued vide this Department OM No.41/21/2000 dated 16/11/2000 for issue of Identity Cards to Central Govt. Pensioners. These instructions have been reiterated vide this Department's letter of even number dated 30th April, 2013.

2. Clarifications have been sought by various Departments/ Associations/ pensioners in regard to issue of Identity Card to Pensioners'. The matter has been examined and the position / clarifications are as under:

(i) Whether National Emblem or Ashoka Chakra is to be printed on Pensioners' Identity Card to facilitate their entry into the Government Buildings.	The pensioners are retired Governmentservants. The Identity Card only establishes the identity of the person and it does not confer any right on the pensioner to enter into a security zone. Therefore, it would not be necessary to have the National Emblem on their Identity Cards.
(ii) Whether Pensioners' Identity Card can be issued to retired employees covered under NPS.	The concerned Ministries / Departments may issue Pensioners' Identity Card (PIC) to retired NPS employees. A revised format for Pensioners' Identity Card, for pensioners retiring under Central Civil Services (Pension) Rules 1972 (or other corresponding rules) is at Annexure I. A format for Pensioners' Identity Card for pensioners retiring under New Pension System is at Annexure II.
(iii) Issue of Pensioners' Identity Card (PIC) to absorbee /pro rata pensioners.	Instructions issued by this Department cover only the retired/retiring

**Grant of transport Allowance to  
Orthopaedically Handicapped Central  
Government employees**

The undersigned is directed to refer to this Ministry's Office Memorandum No.19029/1/78-E.IV(B), dated the 3<sup>rd</sup> December, 1979, as amended from time to time and to say that the criteria for orthopaedically handicapped employees to draw Transport Allowance at double the normal rates has been reviewed in consultation with the Ministry of Health and Family Welfare. It has been decided that in partial modification of Para.I of Office Memorandum, dated 3<sup>rd</sup> December, 1979 referred above. Double Transport Allowance shall be allowed to an orthopaedically Handicapped Government employee if he or she has a minimum of 40% permanent partial disability of either one or both upper limbs or one or both lower limbs OR 50% permanent partial disability of one or both upper limbs and one or both lower limbs combined. The other conditions of O.M., dated 3<sup>rd</sup> December, 1979 for granting double Transport Allowance to orthopaedically handicapped Central Government employees shall remain unchanged.

**Period of retention of General Pool  
accommodation on retirement of allottees**

Consequent upon amendments in Supplementary Rules 317-B-II and 317-B-22 of Allotment of Government residences (General pool in Delhi) Rules, 1983 vide Notification of even number, dated 19-6-2013, the permissible period of retention of General Pool accommodation to the allottees who retire on or after 23-4-2013, is as under:-

- (a) **In cases of accommodation allotted prior to 1-7-2013:**  
2 months on normal licence fee, another 2 months on double of the normal licence fee, further 2 months on four times of the normal licence fee and subsequent 2 months on six times of the normal licence fee.
- (b) **In cases of accommodation allotted on or after 1-7-2013:**  
2 months on normal licence fee, another 2 months on double of the normal licence fee and further 2 months on four times of the normal licence fee

2. It is clarified that the period of retention of 8/6 months, as the case may be, shall be admissible to the allottees, who retire on or after 23-4-2013, automatically at one go without any request or production of certificate by the allottees. The allotment of the General Pool accommodation occupied by the retiring allottees shall be cancelled by Directorate of Estates after allowing a retention of 8/6 months, as the case may be, simultaneously. The allottees, however, shall have an option to vacate the accommodation anytime during the retention period.

3. The retiring allottees shall request their DDOs to deduct the licence fee in respect of the accommodation occupied by them for the period they want to retain the same from their last pay bill and to remit the same online to Directorate of Estates. In case it is not deducted by DDOs, the allottees shall deposit the licence fee in the Directorate of Estates within one month after their date of retirement.

**Sub: Expenditure Management - Economy Measures and Rationalization of Expenditure.**

\*\*\*\*\*

Ministry of Finance, Department of Expenditure has been issuing austerity instructions from time to time with a view to containing non-developmental expenditure and releasing additional resources for priority schemes. The last set of instructions was issued on 31<sup>st</sup> May 2012, 1<sup>st</sup> November 2012 and 14<sup>th</sup> November 2012. Such measures are intended at promoting fiscal discipline, without restricting the operational efficiency of the Government. In the context of the current fiscal situation, there is a need to continue to rationalize expenditure and optimize available resources. With this objective, the following measures for fiscal prudence and economy will come into immediate effect:-

**2.1 Cut in Non-Plan expenditure:**

For the year 2013-2014, every Ministry/Department shall effect a mandatory 10% cut in non-Plan expenditure excluding interest payment, repayment of debt, Defence capital, salaries, pension and the Finance Commission grants to the States. No re-appropriation of funds to augment the Non-Plan heads of expenditure on which cuts have been imposed, shall be allowed during the current fiscal year.

**2.2 Seminars and Conferences:**

- (i) Utmost economy shall be observed in organizing conferences/Seminars/workshops. Only such conferences, workshops, seminars, etc. which are absolutely essential, should be held wherein also a 10% cut on budgetary allocations shall be effected.
- (ii) Holding of exhibitions/seminars/conferences abroad is strongly discouraged except in the case of exhibitions for trade promotion.
- (iii) There will be a ban on holding of meetings and conferences at five star hotels.

### **2.3 Purchase of vehicles:**

Purchase of vehicles is banned until further orders, except against condemned vehicles.

### **2.4 Domestic and Foreign Travel:**

- (i) All officers are to travel in economy class only for domestic travel, except officers in the Apex Scale who may travel in executive class. Officers may travel by entitled class for international travel, however officers in Apex scale may travel only by business class. In all cases of air travel, only the lowest fare air tickets of the entitled class are to be purchased/ procured. No companion free ticket on domestic/ international travel is to be availed of. The existing instructions regarding travel on Leave Travel Concession (LTC) would continue.
- (ii) It would be the responsibility of the Secretary of each Ministry/Department to ensure that foreign travel is restricted to most necessary and unavoidable official engagements based on functional necessity, and that extant instructions are strictly followed.
- (iii) Where travel is unavoidable, it will be ensured that officers of the appropriate level dealing with the subject are sponsored instead of those at higher levels. The size of the delegation and the duration of visit will be kept to the absolute minimum.
- (iv) Proposals for participation in study tours, workshops/ conferences/ seminars/presentation of papers abroad at Government cost will not be entertained except those that are fully funded by sponsoring agencies.
- (v) Travel expenditure (including FTE) should be so regulated as to ensure that each Ministry remains within the allocated budget for the same. Re-appropriation proposals on this account would not be approved.

### **2.5 Creation of Posts:**

- (i) There will be a total ban on creation of Plan and Non-Plan posts.
- (ii) Posts that have remained vacant for more than a year are not to be revived except under very rare and unavoidable circumstances and after seeking clearance of Department of Expenditure.

### **3. Observance of discipline in fiscal transfers to States, Public Sector Undertakings and Autonomous Bodies at Central/State/Local level:**



- 3.1 Release of Grant-in-aid shall be strictly as per provisions contained in GFRs and in Department of Expenditure's OM No.7(1)/E.Coord/2012, dated 14.11.2012.
- 3.2 Ministries/Departments shall not transfer funds under any Plan schemes in relaxation of conditions attached to such transfers (such as matching funding).
- 3.3 The State Governments are required to furnish monthly returns of Plan expenditure – Central, Centrally Sponsored or State Plan – to respective Ministries/Departments along with a report on amounts outstanding in their Public Account in respect of Central and Centrally Sponsored Schemes. This requirement may be scrupulously enforced.
- 3.4 The Chief Controller of Accounts must ensure compliance with the above as part of pre-payment scrutiny.


**4. Balanced Pace of Expenditure:**

- 4.1 As per extant instructions, not more than one-third (33%) of the Budget Estimates may be spent in the last quarter of the financial year. Besides, the stipulation that during the month of March the expenditure should be limited to 15% of the Budget Estimates is reiterated. It may be emphasized here that the restriction of 33% and 15% expenditure ceiling is to be enforced both scheme-wise as well as for the Demands for Grant as a whole, subject to RE ceilings. Ministries/ Departments which are covered by the Monthly Expenditure Plan (MEP) may ensure that the MEP is followed strictly.
- 4.2 It is also considered desirable that in the last month of the year payments may be made only for the goods and services actually procured and for reimbursement of expenditure already incurred. Hence, no amount should be released in advance (in the last month) with the exception of the following:
- (i) Advance payments to contractors under terms of duly executed contracts so that Government would not renege on its legal or contractual obligations.
  - (ii) Any loans or advances to Government servants etc. or private individuals as a measure of relief and rehabilitation as per service conditions or on compassionate grounds.
  - (iii) Any other exceptional case with the approval of the Financial Advisor. However, a list of such cases may be sent by the FA to

the Department of Expenditure by 30<sup>th</sup> April of the following year for information.

- 4.3 Rush of expenditure on procurement should be avoided during the last quarter of the fiscal year and in particular the last month of the year so as to ensure that all procedures are complied with and there is no infructuous or wasteful expenditure. FA's are advised to specially monitor this aspect during their reviews.
5. No fresh financial commitments should be made on items which are not provided for in the budget approved by Parliament.
6. The instructions would also be applicable to autonomous bodies.
7. **Compliance**

Secretaries of the Ministries/Departments being the Chief Accounting Authorities as per Rule 64 of GFR shall be fully charged with the responsibility of ensuring compliance of the measures outlined above. Financial Advisors shall assist the respective Departments in securing compliance with these measures and also submit an overall report to the Minister-in-Charge and to the Ministry of Finance on a quarterly basis regarding various actions taken on these measures/guidelines.
