All Nodal Offices are hereby informed that PFRDA has issued a directive that in line with OM no.: 38/41/06/P&PW (A) dated May 5, 2009 issued by DoPPW and OM no.: 1(7)/DCPS(NPS)/2009/TA/221 dated July 2, 2009 issued by office of Controller General of Accounts, Department of Expenditure, a 'No Objection' from the concerned Nodal Office is necessary to settle the claim in favour of the claimant(s) for the subscribers who have died in harness or became invalid during service. The aforesaid circulars are enclosed for reference.


As advised by PFRDA, the Nodal Offices are required to provide a confirmation that no family pension /disability pension has been paid to the concerned family members as per the above OMs (the OMs are enclosed for reference) and the Nodal Offices have no objection for release of the accumulated pension wealth to such claimant(s). Withdrawal requests of deceased subscribers are liable to be rejected in case 'No Objection' has not been provided by the concerned Nodal Office alongwith the Withdrawal request of the deceased subscriber. The format in which the No Objection is to be submitted by the offices is attached as Annexure.
