**Subject: 15 day workshop (16<sup>th</sup>- 30<sup>th</sup> May 2015) organized by  
IGNOU with respect to CPPDPT-matter reg.**

Madam / Sir,

In continuation to letter F. 110338/40/2010/KVSHQ/Acad/ dated 8.05.2015, the matter of postponement of 15 day face-to-face programme, as mentioned in the subject cited above, was discussed with IGNOU authorities. KVS has been informed that postponement of face-to-face programme scheduled from 16<sup>th</sup>- 30<sup>th</sup> May 2015 is not feasible. However, keeping in view the requests pouring in from different sources for postponement of CPPDPT, 15 day face-to-face programme, it has been decided by KVS HQ that exemption from attending the Workshop Based Activities (WBA) to the teachers concerned applying for the same may be granted by the Deputy Commissioner of the concerned region on case-to-case basis. Such teachers who seek the exemption, and are granted the same by Competent Authority (Deputy Commissioner of the Concern), will have to attend the WBA programme of the 3<sup>rd</sup> Phase which will probably be held during Sept-Oct, 2015 and accordingly such teachers will then be eligible to appear in the CPPDPT examination tentatively scheduled to be held in December 2015.

The Deputy Commissioners of all the regions are requested to inform all concerned by taking all suitable measures (as the time is short) including putting this letter on the Regional Office website with further direction to all the Kendriya Vidyalayas under their jurisdiction to publish the same on the School website.
