- 1. The above items are located in the premises of Kendriya Vidyalaya Sangathan, Head Quarter, 18 Institutional Area, Shaheed Jeet Singh Marg, New Delhi -110016 and can be inspected on any working day between 2.30 PM to 4.30 PM from 12.01.2017 to 02.02.2017.
- 2. Tender Form available at www.kvsangathan.nic.in. Cost of tender is Rs 500/-(Five Hundred Only)
- 3. The Tender form can be deposited in the Room No 213, Kendriya Vidyalaya Sangathan Head Quarter, New Delhi upto 2.00 PM of 2nd February 2017.
- 4. Tender will be opened on 2nd February 2017at 3.30 PM.
- 5. An amount of Rs 3000/-(Rupees Three Thousand only) towards the 'Earnest Money' should be deposited with the duly filled tender form through the Account Payee Bank Draft/Pay Order issued by Nationalized Bank in favour of "Kendriya Vidyalaya Sangathan ,Head Quarter" payable at New Delhi
- 6. Bidders may inspect the items on the stipulated date, time & venue.
- 7. The items shall be sold to the highest bidder. The bids are invited for the lot i.e. covering all the items. In no case partial bid would be accepted.
- 8. The Successful bidder has to make full payment, in the form of Demand Draft in favour of "Kendriya Vidyalaya Sangathan", Head Quarter" payable at New Delhi within two days after confirmation, failing which the offer will be cancelled and the EMD shall stand forfeited. The EMD of unsuccessful bidder's shall be returned within one month after the auction date, without any interest.
- 9. No item once disposed to the successful bidder shall be taken back by this Department on any condition whatsoever.
- 10. The successful bidder will be required to lift all the items from the disposal site within five days after the payment of the bid amount. On failure to do so this department shall have the right to forfeit the entire amount of the bidder and dispose the items to alternate bidder. The successful bidder, on their own cost, will also be required to make their own arrangement of transport, labour etc for lifting the disposal items.

- 11. Quotation letter in sealed envelope marked "TENDER FOR DISPOSAL OF OBSOLETE/UNSERVICEABLE ARTICLES" should be addressed to the Assistant Commissioner(Admn.) & (S&S), Kendriya Vidyalaya Sangathan, Head Quarter, New Delhi.
- 12. The quotation must be dropped in the tender box mounted at Room No 213, Kendriya Vidyalaya Sangathan, Head Quarter, New Delhi on or before the due date and time, otherwise it is liable to be rejected. Tenders received after the due date and time or whatsoever ground shall not be considered.
- 13. The bid amount should be given in both in figures and words. Any overwriting or erasing in the figures shall not be considered for acceptance of the rates offered by the whatsoever.
- 14. Each page or tender document should be signed by the bidders(s).
- 15. Incomplete and unsigned quotations are liable to be rejected.
- 16. Bidder must enclose copy of address proof (Voter I-Card/Aadhar Card) and PAN Card along with his bid.
- 17. The DD/Banker Cheque for EMD of Rs 3000/-(Rupees Three Thousand only) and for Tender cost of Rs 500/-(Rupees five hundred only) must accompany the quotation, without which the bid shall be summarily rejected at initial stage itself.
