Madam/Sir,

With reference to the subject cited above this is to inform that KVS has appointed PGT, TGT (AE,WE and P&HE), PRT(Music) & Librarian in November, 2019 and PRTs, TGTs (Hindi, Eng., Sanskrit, Science, Maths, Social Studies), ASO, SSA, and JSA appointed in January, 2020 from Reserve Panel on direct recruitment.

KVS(HQ.) has received various representations from the newly recruited candidates from Reserve Panel for extension of joining time from your office and many candidates are also approaching KVS(HQ.) directly with extension requests. Hence, Deputy Commissioners, KVS, Regional Offices have been authorized by the Commissioner, KVS to grant extension of time to the needy candidates to join the place of posting with the following riders:-

 Women candidates, who are in family way, may be given extension in time to join the place of posting as per Para 2 of the offer of appointment in terms of extension in joining time.

Candidates, who are working in other department/organization, may be given reasonable time for clearance from the parent department/organization but not more than 04 months from the date of issue of offer of appointment.

PH candidates and candidates, who are pursuing higher studies as regular students at the time of issuance of offer of appointment may be given extension if applied for keeping in view their difficulties/requirements but not more than six months from the date of issue of offer of appointment.

4. All other candidates not included in above provisions but requested for extension in joining time beyond 45 days, Deputy Commissioner may consider their request of extension for further 45 days i.e. total 90 days from the date of issue of offer of appointment in exceptional cases where he/she is absolutely satisfied with the genuineness of case.

You are, therefore, requested to do the needful at your own level immediately.
