महोदया/महोदय,

उपर्युक्त विषय के संदर्भ में सूचित किया जाता है कि अनुकंपा नियुक्ति के संबंध में कुल 720 आवेदन प्राप्त हुए थे। भारत सरकार के नियमों को ध्यान में रखते हुए सभी 720 अभ्यर्थियों के आवेदनों की संवीक्षा की गई तथा विभिन्न विशेषताओं के परीक्षण के उपरांत सापेक्ष योग्यता बिंदु के अवरोही क्रम में निम्नलिखित रिक्तियों को भरने के लिए एक योग्यता सूची तैयार की गई है:

रिक्तियों की संख्या	07	30	37

तदनुसार, कनिष्ठ सचिवालय सहायक के पद के लिए उच्चतर सापेक्ष योग्यता अंक और अपेक्षित योग्यता वाले 07 अभ्यर्थियों का चयन किया गया है (क्रमांक 1 से 8 तक क्रमांक 4 को छोड़कर) तथा 30 अभ्यर्थियों का चयन सब-स्टाफ के पद के लिए (क्रमांक 4 और 9 से क्रमांक 37) उनकी योग्यता, सापेक्ष अंकों, शैक्षिक योग्यता, आयु (जन्म तिथि) और रिक्तियों की उपलब्धता के आधार पर चयन किया गया है। क्रमांक 4 पर उल्लिखित अभ्यर्थी के पास कनिष्ठ सचिवालय सहायक के उक्त पद के लिए अपेक्षित योग्यता (अर्थात न्यूनतम कक्षा बारहवीं उत्तीर्ण) नहीं है, इसलिए उसका नाम सब स्टाफ के लिए प्रस्तावित किया गया है।


चूंकि, क्रमांक 36, 37 और 38 के अभ्यर्थियों के बीच एक समान योग्यता अंक (योग्यता अंक=85) होने के कारण टाई हैं। अतः इस संबंध में, आयु में बड़े अभ्यर्थी को वरीयता दी गई है, तदनुसार क्रमांक 36 और 37 के अभ्यर्थियों को वरीयता प्रदान की गई है, क्योंकि क्रमांक 36 के अभ्यर्थी की जन्म तिथि (11.11.1986) और क्रमांक 37 के अभ्यर्थी की जन्म तिथि (10.02.1989), क्रमांक 38 के अभ्यर्थी की जन्म (04.05.1989) से पहले है, इसलिए क्रमांक 36 और 37 के अभ्यर्थियों को क्रमांक 38 की अपेक्षा नियुक्ति के लिए प्राथमिकता दी गई है।



तदनुसार, वर्ष 2020 और 2021 के लिए अनुकंपा नियुक्ति हेतु चयनित 37 अभ्यर्थियों की सूची के साथ-साथ क्रमांक 01 से 720 तक के सभी अभ्यर्थियों की सूची, जो सापेक्ष योग्यता बिंदुओं को दर्शाती है, अनुलग्नक-1 के रूप में संलग्न है।

अतः अनुरोध है कि इसे अपने क्षेत्रीय कार्यालय के सभी संबंधितों के संज्ञान में लाया जाए और इस संबंध में प्राप्त अभ्यावेदन, यदि कोई हो, को तदनुसार अपने स्तर पर निपटाया जाए।

Sub:- Compassionate Appointment for the year 2020 and 2021 -reg.

Madam/Sir,

With reference to the subject cited it is to inform that a total of 720 applications were received pertaining to Compassionate Appointment. The applications of all 720 candidates scrutinized in terms of the GOI rules and a merit list has been prepared in descending order of relative merit point after examining various attributes to fill up the following vacancies:

Post Name	JSA	Sub-Staff	Total
No. of vacancies	07	30	37

Accordingly, 07 candidates having higher relative merit point & requisite qualification have been selected for the post of JSA (from Sl.No. 1 to 8 except Sl.No.4) and 30 candidates selected for the post of Sub-Staff (from Sl.No. 4 and 9 to 37) as per their relative merit points, educational qualifications, age(DoB) and availability of vacancies. The candidate at Sl. No. 4 is not having requisite qualification (i.e. minimum class-XII passed) for JSA, hence, his name is proposed for sub staff.

Since, there is a tie between the candidates at Sl. No.36, 37 and 38 as they are having same merit point (i.e. 85 merit point). In this regard, preference has been given to the candidate who is elder in age, and therefore, the candidates at Sl.No. 36 as well as 37 have been given preference, as the date of birth (i.e. 11.11.1986) at Sl. No.36, and the date of birth (i.e. 10.02.1989) at Sl. No.37 being

prior the date of birth (i.e. 04.05.1989) of the candidate at Sl. No.38 and hence, both candidates at Sl. No. 36 & 37 have been given priority for selection to be appointed as compared to the candidate at Sl. No.38 in the merit list.

Accordingly, the list of all candidates from Sl.No.01 to 720 reflecting **relative merit points** is enclosed as **Annexure-I** along with the **list of 37 candidates selected for compassionate** appointment for the year 2020 and 2021.

**You are, therefore, requested to bring the same to the notice of all concerned in your region and representation, if any, received in this regard may be disposed of at your end accordingly.**


