The candidature of the applicant shall be cancelled at any stage, even after conduct of examination and issue of Posting Order or even after joining Promotional post after passing the LDE, if found, that the particulars filled by the candidate are/ were incorrect or he/she is not eligible for the post of **FINANCE OFFICER/ SECTION OFFICER** as per Recruitment Rules of KVS for the particular post and fulfillment of other terms and conditions for selection.

6. The Limited Departmental Examination for the post of Finance Officer and Section Officer is an Online Computer based Examination, which will be conducted at Delhi/NCR only.


