The undersigned is directed to forward a copy of letter dated 24.09.2011 on the above mentioned subject for action as appropriate. The matter has been examined and it is observed that as per Rule 14(8) of the CCS (CCA) Rules, 1965, a Defence Assistant may be a Government servant, a retired Government servant or a legal practitioner. For the organizations which have adopted CCS(CCA) Rules, 1965, 'Government servant' would mean employee of that organisation.

2. ~~The suggestion~~ in the letter no. 9-5/85/KVS (Vig.) dated 19.12.1985 regarding restricting of choice of the delinquent officer of KVS to have a Defence Assistant from out of KVS employees only is, in order.

3. In case, clarification/interpretation of any of the rule position is required, the proposal may be referred to this Department in accordance with the procedure laid down in this Department's OM No. 43011/9/2014-Estt.(D) dated 13.02.2015.

Subject:- Permission to allow persons other than
Kendriya Vidyalaya Sangathan employees to act
as Defence Assistants - clarification regarding

Sir,

1. I am to say that references have quite often been received from various quarters seeking clarifications as to whether Govt. employees other than those belonging to Sangathan can be permitted to act as Defence Assistants in departmental proceedings. In this connection, it is clarified that CCS(CCA) Rules, 1965 have been extended to the employees of the Kendriya Vidyalaya Sangathan mutatis-mutandis. Accordingly, wherever the words "Government servant" occur in those rules, these may be interpreted to mean "an employee of the Kendriya Vidyalaya Sangathan." This implies that a charged employee of the Sangathan can take the assistance of an employee belonging to the Kendriya Vidyalaya Sangathan only.

2. It has also been noticed that some of the Inquiring Authorities have allowed persons other than Kendriya Vidyalaya Sangathan employees to act as Defence Assistants. Such Defence Assistants may, as a special case, be allowed to continue but fresh cases should be dealt with in accordance with the clarification given above.
