
MEMORANDUM

On the recommendation of the Departmental Promotion Committee for filling up the vacant post of ADC (Acad.) for the year 2014-15, the Competent Authority has approved promotion of **Shri U.N Khaware, Joint Commissioner(Admn.), KVS(HQ), New Delhi** to the post of **Additional Commissioner (Academic)** in the revised Pay Band-04 scale of pay ₹ 37400-67000 with Grade Pay ₹ 8700 in the Kendriya Vidyalaya Sangathan(HQ), New Delhi subject to the outcome of the OA No. 747/2015 pending before Hon'ble CAT Principal Bench, Delhi.

2. He may convey his acceptance within 07 days from the receipt of this Memorandum if the offer is acceptable to him and he is willing to join at the place of posting mentioned in Para 1 above.

3 His pay in the above scale of pay i.e. Additional Commissioner (Acad.) will be fixed as per provision of FR 22(I)(a)(1) and as per instructions set-forth in Govt. of India, Ministry of Finance OM No.F:1/1/2008-IC dated 13.9.2008 as applicable to the employees of KVS. He will have an option to get his (i) pay fixed from the date of promotion OR (ii) pay fixed from the date of accrual of next increment in the scale of pay of lower grade held by him. The option shall be exercised by him within one month from the date of joining on promotion and option once exercised will be final.

4 If he does not submit the acceptance by the stipulated date, it would be presumed that he has declined/refused the offer of promotion. Refusal of promotion would entail no fresh offer of promotion being made to him for a period of ONE YEAR from the date of refusal. Further, in case of refusal he, on eventual promotion to the above post, will lose seniority vis-a vis erstwhile junior promoted to the above post earlier.
