Subject: Declaration of Assets and Liabilities by public servants under section 44 of the Lokpal and Lokayuktas Act, 2013 – Regarding.

Sir/Madam,

I am to refer to this office letter of even number dated 23.06.2016 and 16.09.2016 on the above mentioned subject.

In this regard it is to inform that as per Govt. of India, DoPT O.M. No. 407/16/2016-AVD-IV(LP) dated 01.12.2016 (copy enclosed), the Public Servants (Furnishing of Information and Annual Returns of Assets and Liabilities and the Limits for Exemption of Assets in Filing Returns) Rule 2014 and all the amendments made thereto have become redundant with the passing of the Lokpal & Lokayuktas (Amendment) Act, 2016.

Hence there is no requirement for filing of declarations of assets and liabilities by Public Servants now and instructions issued vide KVS(HQ) letter dt. 23.06.2016 & 16.09.2016 above may be ignored. The Government is in the process of finalizing a fresh set of rules. The said rules will be notified in due course to prescribe the form, manner and timelines for filing of declaration of assets and liabilities by the public servants under the revised provision of the said Act. All public servants will henceforth be required to file the declarations as may be prescribed by the fresh set of rules.

This issues with the approval of the Competent Authority.
