Subject: Conduct of 2<sup>nd</sup> spell of In-Service Training Course (ISC)-2020 for PGT/TGT (except TGT WE/Art/Lib/PH&E) & PRT (except PRT Mus.) - Revised.

## Madam/sir;

Every Year KVS conducts In-service courses for its teachers in two spells of 11/12 days during summer break and 10 days during winter break via face to face training mode. This year too ie in 2020-21 the first spell of ISC was planned via face to face mode during May/June (summer break). However due to the Covid-19 pandemic, 1st spell of ISC could not be conducted via face to face mode during the summer breaks. However the In-service courses were conducted in the online mode mainly through the 05 ZIETs and IIT Gandhinagar. Seeing the present situation of Covid-19, it has been decided to conduct the 2nd spell of 10 days inservice courses also in online mode only.

The competent authority has accorded approval for the conduct of 2nd spell of ISC-2020 in online mode staggered between October to December 2020 as per schedule given below:

The online ISC-2020(2nd spell) will be conducted as online sessions for 04 hours with each session of one hour duration and one offline session (one hour) for assignment/projects. Some time slot may also be earmarked within 4 hours duration of online sessions for interaction and collaboration. The course will be conducted using the platform Life-size/ Google meet etc.

Deputy Commissioner, all KVS Regional Offices are requested to instruct all the Principals of concerned Vidyalayas of your region with the instruction to inform and ensure that the nominated teacher participates in the online ISC-2020 (2nd spell).

The training sessions for the ISC 2020(2<sup>nd</sup> spell) will begin from from 11:00 am onward. Teachers will take their respective online classes in the school accordingly.

The Director (In charge), ZIETs are requested to depute one Assistant Commissioner (from regional office of any one of the feeder regions) in the concerned ZIETs to act as Course Director.

Same norms of expenditure as in offline mode are applicable for online course also especially regarding payment of honorarium to guest speakers, course directors, associate course directors, resource persons etc.
