I am to refer to this office letter of even no dated 17/04/2018, on the subject cited above and to say that as per practice first screening committee has been constituted for screening of applications for Award to teachers for Innovation & Experimentation. The members of committee reviewed the proposals on 25th & 26th October, 2018 in KVS(HQ) New Delhi and selected 07 entries of PRT and 10 of TGT/PGTs from the secondary and senior secondary level as per details given in **ANNEXURE – A**.

In the terms of para 8.20 of this office letter dated **17/04/2018**, the short listed candidates will be invited to KVS(HQ) to present their project personally on the date decided by this office before the final selection committee now. It has been decided to conduct selection of Innovation and Experimentation Projects from Primary category on **26th November, 2018** and for secondary/senior secondary category on **27th November, 2018**. Those teachers who will be called for presentation of their project will be paid TA/DA as per rules.

Accordingly, it is requested to issue necessary direction to the teacher concerned of Kendriya Vidyalaya as mentined in **ANNEXURE – A** through Principal to present their project personally on **26th November, 2018** for Primary Teachers and 27th **November, 2018** for TGT/PGTs. They should report at **9:30 AM** positively at KVS(HQ) New Delhi and bring their all related documents /materials of project which have been submitted earlier. Each teacher will be given 10 minutes of time to explain their Innovation and Experimentation project.

If more than one teacher are contributed in the project only one teacher should be deputed for presenting their Innovation and Experimentation Project. In case, any teacher fails to appear to present their project on the said dates before the selection committee, their claim will not be considered. Accoridngly, He/She will be dropped out from the list. As such, it is the responsibility of the teachers concerned to make necessary boarding and lodging arrangements in this regard. The teachers will be provided the facility of Computer/LCD Projector etc to present their projects.
