reg**


Madam/Sir,

This is with reference to letter dated 18.04.2021 received in KVS(HQ) from General Secretary AIKVTA wherein he has raised certain issues over the ongoing process of verification of membership of three teaching staff associations (02 recognized and 01 proposed but not recognized yet). The matter has been examined on file and Commissioner KVS has taken a considered view. The following decisions have been taken accordingly, keeping in view Covid 19 pandemic :-

1. Authorization letter from teachers (as specified in KVS letter dated 16.02.21 and 18.03.21) can be obtained on line and submitted on line to DDO/Principal by the Associations. The same is to be accepted by the DDO/Principal.
2. Due to mandatory requirement of verification of new proposed third Association (in 2021) for teaching staff, authorization given in 2020 for already existing associations cannot be accepted. All associations of teaching staff have to obtain fresh authorization from teachers (on line/off line) to arrive at a conclusive figure for recognition for administrative reasons and as per provisions.

Suitable instructions may accordingly be issued to the Principals of Kendriya Vidyalayas functioning under administrative jurisdiction of your Region for compliance.
