- The employees will have the option to get their pay fixed from the date of promotion or from the date of increment in the lower post, i.e., on 1<sup>st</sup> July. The option should be exercised within a month of promotion.
- 4. No extension of joining time shall be allowed except for reasons of illness/ confinement of the employee duly supported by medical certificate from Chief Medical Officer / Medical Supdt. / Civil Surgeon of Govt. Hospital / Distt. Hospitals or from Chief Medical Officer of the Hospital of Public Sector Undertakings/Projects to which the school is attached/Military or Command hospital as a case may be. The request, if any, for extension should be submitted through proper channel by 28.04.2014 to KVS (HQ) positively.
- It is also made clear that representation for either change of place of posting on promotion or for extension of time to join the post (other than covered under para 4 above will not be entertained under any circumstances.
