- 2. They may convey their unconditional acceptance/consent up to <u>28.2.2014</u> to KVS (Hqrs.) quoting the above reference through the Principal of their Vidyalaya under intimation to the office of the Deputy Commissioner, Regional Office concerned also, if the offer is acceptable and they may join at the place of posting mentioned in paragraph 01 above latest by <u>7.3.2014</u> after availing minimum joining time, as admissible under rules.
- 3. Their pay in the above scale of pay i.e. Vice-Principal will be fixed as per provision of FR 22(1)(a)(1) and as per instructions setforth in Govt. of India, Ministry of Finance OM NO.F.1/1/2008-IC dated 13.9.2008 as applicable to the employees of KVS. They will have an option to get their (i) pay fixed from the date of joining on promotion OR (ii) pay fixed from the date of accrual of next increment in the scale of pay of lower grade held by them. The option shall be exercised by them within one month from the date of joining on promotion and option once exercised will be final.
- 4. In case, they do not want to accept promotion to the above post, they should make a written request to the appointing authority declining the same setting out reasons for such refusal. Refusal of promotion will entail no fresh Offer of promotion being made to individual concerned for a period of **ONE YEAR** from the date of refusal. They, on eventual promotion to the above post, will lose seniority vis-à-vis erstwhile juniors promoted to the above post earlier, irrespective of the fact whether the post in question is filled by selection or seniority.

5. This promotion is subject to the condition that no disciplinary case is pending against any PGT and they are not under currency of any penalty.
